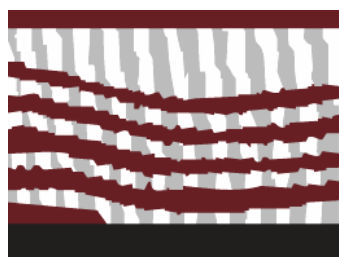

¹ The term prescribed body corporate (PBC) derives from Part 2 Division 6 of the *Native Title Act 1993*, which provides that a prescribed body corporate must be determined to manage native title rights and interests. The Native Title (Prescribed Bodies Corporate) Regulations 1999 prescribe the form or types of bodies that may be nominated when a determination recognising native title has been made. The term Registered Native Title Body Corporate (RNTBC) derives from the *Native Title Act 1993* (NTA) and describes the organisation that is determined by the Court and entered on the National Native Title Register. Under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* an RNTBC will be required to have the words 'registered native title body corporate' or the abbreviation 'RNTBC' as part of its name. For the purpose of this document from this point forward the abbreviation RNTBCs will be used to refer to Prescribed Bodies Corporate and Registered Native Title Bodies Corporate.

1.1 Searching for Funding

A comprehensive guide to community grants that may be of value to PBCs is available on the webpage of the [Parliamentary Library: A Guide to Community Grants](#). Information is provided about commonwealth, state and territory; private; as well as commercial services community grants.

The Department of Infrastructure, Transport, Regional Development and Local Government maintain GrantsLINK which is a constantly-updated database of grants and funding opportunities across all Australian Governments and some community organisations. Similarly, the Grants and Services Finder, maintained by the Commonwealth Department of the Environment, Water, Heritage and the Arts, provides over 1400 grants from local, state and federal government as well as private sources.

Funding for some indigenous programs can be found at [ESub](#) as well as through department specific indigenous funding webpages. Grants specific to other departments can be identified through each of their grants webpages. Table 1 provides links for searching for government funding. 2. TRAINING INFORMATION

RNTBCs may require information about training initiatives to ensure that native title holders are able to deal with issues of decision-making, dispute management, communication, governance, business management, as well as land and resource management. This section discusses training opportunities and training resources.

The [Office of the Registrar of Indigenous Corporations](#) (ORIC) currently provides a range of training and information sessions for Indigenous corporation. Diploma in Business (Governance)	Provides a nationally recognised training package for Indigenous people to further develop their governance skills. 13 units of competency are covered over five one-week blocks (Monday to Friday) over a period of 6–12 months. To be eligible to start this course you must have completed the Certificate IV in Business (Governance), and have year 12 education or ability to demonstrate equivalent literacy, numeracy and analytical skills.
